HLA.270/2020/69: In the interest of providing medical relief and financial assistance to the poor and needy people of the State and in view of the outbreak of COVID-19 pandemic, Govt. of Assam has decided to create and establish the "Assam Arogya Nidhi Trust" in place of existing "Assam Arogya Nidhi Scheme" to provide financial and health care services to all eligible persons suffering from various serious diseases including COVID-19 under "Assam Arogya Nidhi Scheme".

Accordingly "Assam Arogya Nidhi Trust" is hereby constituted vide Registration No. 5527/2020 and notified with the following trustees.

The existing Bank Account in the name of "Assam Arogya Nidhi Scheme" shall continue as the Bank Account of the "Assam Arogya Nidhi Trust". The existing fund and other assets of "Assam Arogya Nidhi Scheme" shall be the property of the Trust.

The Bank Account shall be operated jointly by the Mission Director, NHM, Assam and Director, Finance & Accounts, National Health Mission, Assam as earlier.

This comes into force with immediate effect and shall remain in force until further orders.
