ORDER

Whereas, the State Government has received a number of requests from stranded persons across the State of Assam for permission to travel from one location to another location within the State;

Whereas, no such permission could be granted to stranded persons so far due to strict lockdown measures in place due to COVID -19 pandemic;

Whereas, additional new activities, outside the containment zones, have been permitted in the consolidated revised guidelines of Government of India with effect from 21st April, 2020;

Now, therefore, in light of the above, the Government of Assam, has decided to allow one time inter-district movement of persons within the State belonging to following categories who are facing genuine compelling circumstances. However, this relaxations will not apply to Dhubri, Morigaon, Nalbari, Golaghat and Goalpara districts.

1. Medical grounds

- 1.1.1. Patients who would like to return to their homes in another district or to travel to another district for treatment will apply to the Deputy Commissioner (of present place of stay) for e-pass.
- 1.1.2. Such persons will be allowed to and fro journey depending upon Deputy Commissioner being satisfied that the grounds are genuine and valid.

2. Non- medical grounds:

Following individuals fall in this category :-

- a) Central Government employees/ private sector employees/ Public Sector Undertaking employees who are stranded either at place of work or at home and would like to travel to either place of work or residence.
- b) Private individuals having compelling reason to travel to a location in another district fall in this category.
- c) Students who would like to travel to their homes.

2.1. Persons with arrangement of private vehicles from place of origin.

- 2.1.1. One way travel will be allowed.
- 2.1.2. Such persons will contact Deputy Commissioner (of present place of stay) for issue of e-pass.

2.2 Workers/ labourers/ staff of contractors/ firms/ industries etc.

2.2.1 The Contractors/ firms/ industries etc. will apply to concerned Deputy Commissioner (of present place of stay of the workers/ labourers/ staff) for e-pass and higher bus etc. of their own for transport.

3. Persons who require public transportation

- 3.1.1. State Government will arrange transportation through ASTC. Certain pickup and drop-off points will be identified in each location.
- 3.1.2. Such persons will call # 104 helpline and provide all necessary details including current address, destination etc. so that ASTC will notify the routes, timings, pick-up and drop-off points etc.

General conditions:

- i. The aforesaid movement within the State will be allowed on 25th, 26th & 27th April, 2020.
- ii. No permission to travel to another State will be granted. Grant of permission by Deputy Commissioner will be subject to satisfaction that grounds are genuine and valid.
- iii. For persons travelling under category 1 & 2, online application on e-pass needs to be submitted in concerned district as per link mentioned in Annexure-I, along with name and contact number of district nodal officer. Deputy Commissioner will issue the e-pass based on his satisfaction taking into consideration the contents of the applications with the supporting documents so submitted.
- iv. For persons falling under category 3, who require public transportation, they have to call # 104 helpline and provide all necessary details to avail public transportation. In case of public transport, preference will be given to persons requiring medical attention, stranded labour, elderly people, students etc.
 - v. During the journey, it would be ensured by all concerned that safe social/ physical distancing, hygiene, sanitization etc. norms are followed as per the extant guidelines. Suitable medical screening etc. will be carried out by the local Deputy Commissioner as per existing guidelines.
- vi. Applications to Deputy Commissioner will be accepted during office hours on 23rd & 24th April, 2020 and calls to # 104 helpline will be received till 23:55 hours of 24th April, 2020.
- vii. Movement of all vehicles should be point to point through the most direct route without any provision for night stay.
