## **ORDER**

Whereas, in pursuance to the directions of Hon'ble Supreme Court vide Para 12 of the order dated 19.06.2020 in SMWP (C) No. 07/2020 teams of domain knowledge experts comprising of doctors from AIIMS, Delhi, DGHS, MoHFW and GNCTD Delhi was constituted for rapid assessment of the existing capacity, patient care amenities and associated aspects of the covid care facilities in the GNCTD of Delhi in order to inform efficient and timely decision making.

Whereas, Department of Health & Family Welfare, GNCTD vide Order dated 30.07.2020 constituted four committees comprising of Specialists, two from internal medicine and another two from anaesthesia, was constituted for inspecting identified private hospitals to examine whether the standard treatment protocols for treating COVID patients were being followed therein and also for analysing the reason for higher percentage of COVID beds and cause for death of patients occurring in ward

Whereas, this Directorate vide Order Nos. 427/DGHS/PHW-IV/Admn. Policy/COVID-19/2020/113-183 dated 08.04.2021 & 427/DGHS/PHW-IV/Admn. Policy/COVID-19/2020/184-237 dated 08.04.2021 directed all hospitals of Delhi, Government & Private, to strictly adhere to the admission & discharge policy in respect of COVID patients framed by MoHFW, Govt. of India.

Whereas, this Directorate vide Order No. F.23/Misc./COVID-19/DGHS/NHC/2020/Pt. XV/75-81 dated 11.04.2021 directed all hospitals providing COVID related treatment to fill the daily evaluation sheet(s) in r/o COVID ICU/ Ward; COVID discharges & COVID admission details and send the same to this Directorate and also provide a hard copy to the SNO posted in the concerned hospital.

Therefore, in order to scrutinize and audit the daily evaluation sheet submitted by the private hospitals, providing COVID related treatment, two multi-disciplinary teams are being constituted for this purpose and their details are as under:
