ORDER

The guidelines for COVID-19 testing has been revised by Indian Council of Medical Research on 09.04.2020 and the same is as below:

- All symptomatic individuals who have undertaken international travel in the last 14 days
- ii) All symptomatic contacts of laboratory confirmed cases
- iii) All symptomatic health care workers
- iv) All patients with Severe Acute Respiratory Illness (fever AND cough and/or shortness of breath)
- v) Asymptomatic direct and high-risk contacts of a confirmed case should be tested once between day 5 and day 14 of coming in his/her contact

In hotspots/cluster (as per MoHFW) and in large migration gatherings/ evacuees centres

- vi) All symptomatic ILI (fever, cough, sore throat, runny nose)
 - a. Within 7 days of illness rRT-PCR
 - b. After 7 days of illness Antibody test (If negative, confirmed by rRT-PCR)

It has been decided by the competent authority that 20000 rRT-PCR tests are to be performed on a war footing in Delhi in the coming five days for the community under surveillance and patients admitted in COVID-19 designated Delhi Government hospitals/quarantine centres for the timely containment of the disease.

In case the number of samples collected is more than the combined capacity of government labs, the samples collected at COVID-19 designated Delhi Government hospitals/quarantine centres shall be sent to private labs as per their allocated designated areas/regions. The allocation is as under:

- 1. The samples collected at Delhi Government Hospitals / Quarantine Centres / Testing Centres shall be labelled and packed in the transport container having requisite temperature as per protocol.
- 2. The requisite form shall be filled by the person who has collected the sample(s) and the e-mail 1D of the institution on which the report is to be sent shall be mentioned thereupon.
- 3. The runner of the designated private Lab shall receive the transport container alongwith the sample(s) and give a receipt of the same before transporting the same to the Lab.
- 4. The designated private Labs shall send the report at the earliest on the e-mail ID mentioned on the requisition form and E-mail ID: idsplabreporting@gmail.com
- 5. The bills alongwith copy of the requisition form(s) and report of the test(s) shall be submitted by the private Labs to Delhi State Health Mission for payment purposes on a weekly basis.
- 6. In case the designated private lab of Districts at S.Nos. 4 to 11 does not receive the sample or has reached its maximum capacity, the sample may be sent to Dr. Lal Path Labs.

The private authorized / designated Labs shall be paid from the COVID funds released by Government of India under National Health Mission to Delhi State Health Mission at the following rates:
