Stationery Incharge C/o A.C.(W) will ensure that hand sanitizer and thermal scanner for 3 entry gates & 2 reception counters are made available to Dy. C.S.O. for Fleadquarter buildings (Phase-I & Phase-II),
 - Director (Florticulture) will ensure daily sanitization of Headquarter's building (Phase-I ciri & Phiese-H)

OFFICE MEMORANDUM

Subject: Proventive measures to be taken to contain the spread of Newel Coronavirus (COVID-19) - regarding.

The undersigned is directed to circulate the DoPT OM dated 17.03.2020 whereby the precautionary measures to be taken to contain the spread of Novel Coronovirus (COVID-19) have been circulated (copy enclosed). In this togard, it has been decided to implement the said guidelines mutatis mutandis. Accordingly, following advisory is issued for the well-being of all employees serving under ONGT of Delhi, in public interest.

- All the departments / local bodies / autonomous bodies / PSUs etc under Government of NCT of Delhi are advised to take all necessary measures such as
- (i) Install thurmal scanners at the entry of Government buildings, as feasible. Mandatory placing of band sanitizers at the entry of Government buildings. Those found having flu-like symptoms may be advised to take proper treatment/quarantine etc.
- (ii) Discourage, to the maximum extent, entry of visitors in the office complex. Houtine issue of visitors / temporary passes should be suspended with immediate effect. Only those visitors whom have proper permission of the officer, who they want to meet, should be allowed after being properly screened.
- (iii) Meetings, as far as feasible, should be done through video conferencing. To minimize or reschedule meetings involving large number of people unless necessary.
- (iv) Avoid non-essential official travel,
 - Undertake essential correspondence on official email and avoid sending files and documents to other offices, to the extent possible.
 - Facilitate delivery and receipt of dak at the entry point itself of the office building, as far as practicable.
 - Close all gyms/recreation centres/creches located in Government buildings,
 - Ensure proper cleaning and frequent sanitization of the workplace, particularly of the frequently touched surfaces.

- (ix) Ensure regular supply of hand samisacts, soap and running water in the washrooms.
- All officials may be advised to take care of their own headin and look out for respiratory symptoms/fever and, if feeling unwell, should leave the workplace immediately after informing their reporting officers. They should observe home-quarantine as per the guidelines issued by MoH&FW, Government of India available at the following URL: mohfw gov.in/DraftQuidelinesforhomequarantine pdf as well as other guidelines mentioned ar http://health.delhigovt.nic.in/wps/wcm/connect/DoFT Health/health/home/
- (xi) The leave sanctioning authorities are advised to sanction leave whenever any request is made for self-quarantine as a precautionary measure.
- (xii) Advise all employees who are at higher risk i.e. older employees, pregnant employees and employees who have underlying medical conditions, to take extra precautions. The Ministries/Departments may take care not to expose such employees to any front-line work requiring direct contact with the public.
- An indicative list of Do's and Don'ts is annexed for wide dissemination (Annexure-I). List of Control Room Numbers at Headquarters & District Level in GNCT of Delhi is also annexed (Annexure-II).

Sneeze or cough into palms of your hands.


Spit in Public.
