GOVERNMENT ORDER

In exercise of the powers conferred by Government order No. 23/20/2014-I/PHD/Part IV/553 dated 13/03/2020, and in continuation to Government order No.DHS/IDSP/19-20/120/547 dated 14/03/2020 Government of Goa issues the following directives for the purpose of prevention and control of Coronavirus disease (COVID-19):

- 1. The operations of all weekly bazaars shall be suspended.
- 2. All pubs shall remain closed.
- 3. All coaching classes shall be suspended.
- 4. All shopping malls shall remain closed.

This order shall come into effect from 1200 hours of the intervening night between 20/03/2020 and 21/03/2020 and will remain in force till 31/03/2020.

GOVERNMENT ORDER

In exercise of the powers conferred vide notification No. 23/20/2014-I/PHD/Part IV/553 dated 13/03/2020, Government of Goa has decided to take the following measures to prevent and contain Coronavirus disease (COVID-19) in Goa, which will come in force with effect from 00.00 hours, midnight, of the intervening night of 15th and 16th March 2020.

These measures will remain in force until the 31st of March 2020, and the situation of COVID-19 will be reviewed thereafter for future course of action.
