

## **RATION QUOTA FOR THE MONTH OF MAY 2020**

Panaji : April 25, 2020

The Department of Civil Supplies and Consumers Affairs has informed that the ration quota allotted for the month of **May 2020** under National Food Security Act 2013 is as under, The Antyodaya Anna Yojana (AAY) cardholders are allotted the quota of rice of 35 kg. rice per card for Rs. 3/- and 5 kg PM-GKAY rice per beneficiary (Free of cost) and Sugar 1 Kg for Rs. 13.50/- and 3 kg PM-GKAY Turdal per card together for the months of April, May and **June 2020** free of cost.

Under Priority Household (PHH) scheme each beneficiary will get 5 kg Rice at the rate per kg. Rs. 3/- and PN-GKAY rice per beneficiary 5 kg free of cost, Sugar by Government of Goa 3 kg per card together for the months of April, May and **June 2020** for Rs. 13.50/- and PM-GKAY Turdal per card 3 kg together for the months of April, May and **June 2020** free of cost.

Whereas the Above Poverty line (APL) cardholders will get 8 kg. rice per card for Rs. 12.50/- and additional rice by Government of Goa 5 kg per card for Rs.12.50/-, 4 kg wheat per card for Rs. 10/-.and 2kg Turdal by Government of Goa per card together for the months of April, and **May 2020** at the rate per kg. Rs. 83/-. Whereas each (ANP) cardholder will get 10 kg. rice (Free of cost) and turdal by Government of Goa 2 kg per card together for the months of April and **May 2020** at the rate per kg. Rs. 83/-.

The beneficiaries of Welfare Institution Scheme will get rice 15 kgs per inmates either rice/wheat) Rice at the rate per kg.Rs. 6.15/- and wheat 15 kgs per inmates either rice/wheat) at the rate per kg. Rs. 4.80/-.

All the fair price shops owners are informed that the quota lifting should start with immediate effect and they should lift their released quota on or before **May 07, 2020**.strictly and no extension would be granted for lifting. The fair price shops are required to display the details of stock as well as sample quality of grains for consumer information. The ration cardholders are required to take their entitlement for **May 2020** from their respective Fair Price Shops.

All cardholders/consumers are advised to lodge their complaints if any to their respective Jt. Mamlatdar-I of Pernem, Bicholim, Sattari, Tiswadi, Ponda,

Salcete, Mormugao, Quepem, Sanguem, Canacona Talukas and Jt. Mamlatdar-III of Bardez Taluka or with the Department of Civil Supplies and Consumer Affairs, Junta House, Panaji.
