CIRCULAR

In view of letter No.Insp-I/22/2022, dated 10.02.2022, received from the Hon'ble Registrar General, High Court, Bombay, conveying the directions of the Hon'ble the Chief Justice and other Hon'ble Judges of the Hon'ble Administrative Committee to **start normal physical functioning** of all the Subordinate Courts w.e.f. 14.02.2022 to 04.03.2022, all the District and Subordinate Courts in the North Goa District will start functioning as **per pre-pandemic days with 100% attendance** of Judicial Officers and staff in both the sessions w.e.f. **15.02.2022** (as 14.02.2022 being declared holiday for the North Goa District on account of "Polling Day" for the General elections for Legislative Assembly of the State of Goa) till 04.03.2022.

All the Covid-19 safety and precautionary measures (i.e. wearing masks, sanitization, social distancing norms, vaccination, etc.) set forth by the Central Government, State Government and Local Authorities, etc from time to time, shall be adhered scrupulously by all the District and Subordinate Courts in the North-Goa.
