1. This expert committee shall make a visit and inspect all Government, Private, Grant in Aid designated COVID Hospitals in the state with a set check list in working designated pairs of 5 members.

- 2. To perform inspection, supervision of the designated hospitals in the State this experts committee can form a sub-committee as and when required for region wise with the consent of Commissioner (health).
- 3. The committee will do supervision and guidance to implement standard best practices for all aspects of COVID 19 care in state of Gujarat.
- Committee will issue necessary directions to designated hospitals for improvement and point out their challenges and also take note of any good innovations and good practices to be replicated across the state.
- 5. Committee will discuss the non-compliances with the stake holders before leaving site and have a joint report (with before and after evidences, including photographs and audio visual clips) made with signatures of inspecting committee, Dean/MS or other office holders of the institute visited. The time line for submission of ATR will not be exceeding 10 working days.
- All COVID 19 hospitals of the state should be visited by designated committees as per time table made by DD Medical Education in consultation with committee within 7 days of issuance of this order.
- 7. Dr. Gunvant Rathod, Dy. Director, M.E. (I.C.) will timely submits the timely reports to the Government regarding the same.
- 8. To develop comprehensive plans for strengthening public health facilities in Hospital this committee will be advisory to Government.
