Order:

State Government is following "Test-Track-Treatment" guideline to contain COVID 19 pandemic. Treatment is a key aspect in COVID 19 and for that at present State Government is allowing all the COVID 19 patients either RTPCR/RAT/HRCT confirm or suspected to admitted in COVID hospitals.

In the matter of Supreme Court Suo motu Writ Pition(Civil) No. 3/2021 order dated 30/04/2021, the court has directed to have an uniform Policy throughout the State for Admission of Covid Patients in Hospitals.

In the light of the matter by the powers conferred under "The Gujarat Epidemic Diseases, COVID-19 Regulations,2020" of The Epidemic Diseases Act, 1897, The State government is here by clarifies by order to strictly follows the following instructions regarding hospital admission.

1. Positive COVID 19 test report will not be required for admission. Suspected patients having symptoms should be entertained and give treatment.
2. All patients, whether coming in ambulance or private vehicle to be admitted in the Hospitals.
3. Place of residence in a particular city or state will not be a reason for denial of admission to patient.
4. Drugs and oxygen to be made available to all the needy patients.

On the violation of this order competent authority can initiate the action under The Epidemic Diseases Act, 1897.
