Vide order dated 27.03.2021, The State Government has made mandatory negative RTPCR test, conducted in the 72 hours for travelers from other states in Gujarat by the power conferred under The Epidemic Dieses Act, 1897.

Considering the large number of passengers would be arrived at Airport terminals and there is a chance of spread of Covid-19. Hence, all Airlines are instructed to ask for negative RTPCR report of passenger before departure at the origin. Otherwise the passenger may not be allowed to enter in state of Gujarat or passenger has to perform self-paid test at Airport in Gujarat and has to wait till the negative report is not received. All Airlines and Airport Authority are requested to sensitize all passengers regarding COVID appropriate behavior.
