Subject: COVID vaccination strategy for the month of June 2021 till 19.06.2021 Sir/ Madam,

As your are aware that Himachal Pradesh has been implementing the COVID-19 Vaccination drive since 16th January, 2021. So far in the State, 2465448 doses have been administered out of which 2028826 first doses and 43662 second doses have been given. State is continuously working to cover the maximum population in the eligible age groups. The pace of vaccination in the 45 years and above group as per the achievement needs to improve for which the following strategy has been devised for the month of June, 2021 (applicable till 19th June 2021).

To ramp up vaccination, the following decisions are hereby conveyed for strict compliance by all concerned:

- For the vaccination of >45 years of age and priority groups/FLWs/HCWs, Sessions shall be held on 4 working days in a week i.e. Tuesday, Wednesday, Friday and Saturday. Monday and Thursday will be reserved for 18-44 years age group depending on vaccine availability.
- 2. The cut off date for vaccination of the age group of 45 years and above along with HCW,FLW and Prioritised groups is fixed to be 19th June 2021. The persons of the concerned categories may be mobilized to get themselves vaccinated with first dose before 19th June 2021 and widespread IEC may be undertaken in this regard as well.
- 3. 18-44 years vaccination will be based on availability of vaccine and vaccine distribution is based on districts population proportion of census 2011.
- 4. Sessions may be planned as per allocation of vaccine and keeping in view strategies to minimize the vaccine wastage.
- 5. The sessions for 18-44 years of age shall be held on the 14th and 17th of

- June 2021 (Monday and Thursday). Vaccine allocation has been made separately for the same and instructions are also being issued.
- 6. Districts may ensure that the session ends on CoWIN on the same day. In unavoidable circumstances, the session will be closed before 5 pm the next day. Vaccine Utilisation reports mandatorily to be filled by the vaccination team before end of session. Refresher training on the same may be imparted to reduce down errors.
- Cold Chain Handlers to mandatorily ensure that all eVIN entries are done the same day by themselves.
- 8. Follow up of Second Due dose shall be taken up at the district and sub district level based on Second Dose Due and Second Dose Due Alert report derived from CoWIN.
