Subject: 3rd Allocation of State procured 117830 doses with revised COVID vaccination strategy for 18-44 years age group- matter regarding

Sir/ Madam,

This is in continuation to this office letter no. NHMHP-CCVM03/19/1/2021-E31128-21052 dated 09.06.2021 and letter no. NHMHP-CCVM084-B/1/2020-E18102-21064-69 dated 09.06.2021. It is informed that in addition to the 2nd consignment received from the Serum Institute of India of the State procured vaccine, the State is further receiving a consignment of 117830 doses of COVISHIELD to cater to the age group of 18-44 years on 12th June 2021.

The distribution of 3rd consignment of COVISHIELD vaccine (State Procured) to all the districts is being made based on the total population of 18-44 years Age group beneficiaries of the district as per census 2011. A tentative session planning has been indicated to ramp up the pace of COVID Vaccination in the age group of 18-44 years age group. Accordingly, the district wise distribution of above consignment is annexed at 'A'. The vaccine flow would be maintained as per mechanism already established in the state for the districts. FEFO principle shall be strictly followed. The vaccine to Lahaul & Spiti would be distributed @ 65:35 ratio i.e. 65% of total to Lahaul division & 35% of total Spiti division. The following points are to taken care while session planning:

 These vaccines shall be used as per the State approved strategy for Tribal/Hard and other areas as communicated vide letter no. NHMHP-CCV084-B/2/2020-E22712-26887 dated 29th May 2021. The sessions can be published in onsite registration mode/facilitated cohort mobilisation mode in tribal/hard areas with the active cooperation of local administration while in other areas, the sessions would required to be booked online.

- Sessions for 14.06.2021 shall be conducted as per the previous directions of dated 09.06.2021.
- 3. Additional sessions shall be planned with this vaccine on **15.06.2021**, **16.06.2021 17.06.2021 and 18.06.2021**.
- 4. Sessions shall be published for the above mentioned dates (in Sr. No.3) one day prior to the session day between 12 PM to 1.00 PM. For instance, for the sessions to be held on 15th June 2021, the session shall be published on COWIN portal on 14th June 2021 between 12 PM and 1 PM.
- 5. Sessions should be planned for 100 beneficiaries.
- 6. The vaccination of the other prioritised age groups shall be avoided on the same date and site, to avoid chaos and confusion. Districts can also plan sessions for 45 years and above age group/prioritised groups on 15th Tuesday, 16th Wednesday and 18th Friday with Gol Vaccine at other session sites.
- 7. The sites having large catchment areas like urban clusters can be consistent but the sites shall be rotated in the rural areas to ensure equity.
- These sessions can be planned at spacious places like schools etc to avoid overcrowding. However, the cleanliness of such venues be ensured well in advance.
- 9. Liason be established with concerned Deputy Commissioner and Superintendent of Police to ensure adequate management for law and order at these sites.
- 10. If any of the State Procured vaccine is still left with the district after 18th June 2021, a mop up round shall be planned for 19th June 2021 under intimation to the State.
- 11. Overall Tentative sessions per district is given in "Annexure B" for these days and the districts are advised to follow the same.
- 12. Keeping in view, the left out vaccine left with a particular session site after conducting a session for the 18-44 years of age on the 17th of June 2021, session capacity of more than 100 can be published in consultation with the Nodal Incharge for vaccination Center/vaccinator for the sessions planned on 18th June 2021 as per the available vaccine with that particular session site/CCP.

- 13. Sessions shall be extended as per previous guidelines of maximum 9 beneficiaries or remaining doses in the open vial for 15th, 16th and 17th June but for 18th June 2021, sessions may be extended till the vaccine exhausts at the planned COVID Vaccination Centre session exclusively for 18th June 2021 only as per the prescribed mode of publishing.
- 14. Total sessions capacity for CVC in a day would be 100. However if two batches are available, DIO may create 2 sessions subject to the condition that cumulative session capacity of the day will not exceed more than 100 for the above mentioned dates on 15.06.2021, 16.06.2021 and 17.06.2021. For 18.06.2021 sessions capacity to be planned based on exhausting the state procured vaccine in this group as per prescribed mode of publishing.
- 15. Districts will further ensure that only one batch of vaccine will be allocated to a CCP, except under unavoidable circumstances.
- 16. Sessions may be planned as per allocation of vaccine and keeping in view strategies to minimize the vaccine wastage.
