Subject: - Opening of Zojila Pass-Replenishment of essential commodities thereof.

ORDER

In continuation to the order regarding the subject, issued under endorsement No:- DivCom(L)/UTL/SOP/2020/2630-54 dated:-27.03.2020 and in order to replenish essential supplies in Ladakh, Trucks/oil tankers carrying essential commodities for Ladakh will only be allowed to cross through Zojila pass w.e.f. 11th April, 2020. The schedule for the first week, to be followed during the transition of the vehicles into Ladakh is as under:-

S.No	Date/Day	Maximum No. of Trucks/ Tankers to be allowed	Category of vehicle to be allowed to cross Zojila Pass
1.	11.04.2020 Saturday	29	Indian Oil Corporation Ltd. (IOCL) tankers
2.	13.04.2020 Monday	10	Five trucks each of Leh and Kargil carrying vegetables/food items etc.
3.	15.04.2020 Wednesday	14	HPCL trucks (07 each for Leh & Kargil) carrying LPG cylinders
4.	17.04.2020 Friday	15	Trucks carrying vegetables/food items etc for Kargil.
5.	19.04.2020 Sunday	15	Trucks carrying vegetables/food items for Leh
6.	21.04.2020 Tuesday	15	Trucks carrying vegetables/food items etc for Kargil.
7.	23.04.2020 Thursday	15	Trucks carrying vegetables/food items for Leh.

The following conditions will however be followed during the movement of trucks/tankers carrying essential commodities/supplies:-

- i. The trucks/tankers will camp at Sonamarg on the previous evening of movement or early morning by 08:00 A.M on the date of movement.
- ii. In case of cancellation of the movement of trucks/tankers on a particular date due to bad weather etc., the number of trucks/tankers scheduled for that particular date shall be allowed to cross over Zojila on the next day.
- iii. The trucks carrying essential commodities will be transshipped at Minamarg, at location identified by the Deputy Commissioner, Kargil, into local trucks to be arranged by the Indenting agency.

- iv. The requisitioning of essential commodities, their quantity, agency through which the commodities will be procured, mechanism for transshipment and further distribution in all areas of both the Districts will be fixed and monitored by the respective Ladakh Autonomous Hill Development Councils.
- v. The Ladakh Autonomous Hill Development Council, Leh and Kargil will get furnished the list of trucks crossing Zojilla pass on a scheduled date, their registration numbers, name of the driver and one additional staff and their particulars to the Inspector General of Police, Ladakh at least 02 days before the scheduled date of crossing Zojila Pass. Only such drivers/helpers shall be allowed to cross Zojila pass whose name and particulars are provided in advance to the IGP, Ladakh.
- vi. The other conditions related to the movement of trucks/oil tankers carrying essential commodities, shall remain the same as laid down in the Standard Operating Procedures, (SOPs) issued under endorsement No.DivCom(L)/UTL/SOP/2020/2630-54 dated:-27.03.2020.

It is further ordered that Sh. Abied Hussain, (Mob.<u>9622857476</u>), OSD with the Divisional Commissioner, Ladakh shall be the Nodal Officer, who will coordinate with different agencies/stake holders for smooth transition of essential commodities/supplies in Ladakh.
