**O R D E R**


1. WHEREAS, clusters of more than five COVID-19 positive cases have been reported from the following locations, which may otherwise become a probable hotspot of COVID-19, unless strict measures are taken.
2. THEREFORE, the following locations are hereby notified as Micro Containment Zones to contain further spread of the Corona Virus.
