- To wear mask by Shopkeepers and Customers. This is mandatory and non-compliance will entail action of closure of the shops concerned.
- 6. Not to spit in public places.
- 7. Cooperate with management made by the District Administration and District Police.
- Ensure compulsory compliance to conditions in Prohibitory Order No.C&S.3/2009/PT.II/230, Dated Shillong, the 29th June 2020 and Night Curfew Order No.C&S.3/2009/PT.II/231, Dated Shillong, the 29th June 2020 which are promulgated under Section 144 CrPC.
