
Given the prevailing COVID-19 situation, the Government of Meghalaya will be using a new app – CORONTINE, developed by IIT Bombay - that will help people track COVID-19 spread more accurately and effectively.

The Health and Family Welfare Department, Government of Meghalaya has a list of 5300 individuals who fall in the categories below:

- (a) Visited Bethany Hospital, Shillong on or after 24th March
- (b) Visited Bethany Hospital, Nongpoh on or after 30th March
- (c) Been identified as a Primary or Secondary Contact of the Corona Positive Patients

All these individuals are hereby mandated under the provisions of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 to compulsorily download the app and to provide their location coordinates.

These individuals will all receive an SMS or a link via Whatsapp on their mobile phones to download the CORONTINE App.
