Sub: Constitution of GP Level Covid Care Home (CCH) and Cluster Level Temporary Medical Camp (TMC) to fight COVID-19 Pandemic.

Ref: This Department Letter No. 10173/ PR&DW, Dtd. 22.06.2020 & Letter No. 7606 Dtd. 18.04.2020.

Madam / Sir,

With reference to the above cited subject and letters under reference, I am directed to say that it has been decided by the Govt. that;

- 1. Each GP will set up a COVID Care Home (CCH) facility up to 10 beds which shall accommodate positive asymptomatic cases or very mild symptomatic cases for isolation. The COVID Care Home in a GP will be located at Rajiv Gandhi Seva Kendra / Cyclone & Flood Shelter/Community Hall/Kalyan Mandap or any other suitable non educational institutions under the jurisdiction of GP. Adequate care may be taken to ensure that the COVID Care Home should not be located in crowded area of the GP.
- 2. The COVID Care Home will work as an isolation/transit centre for the suspected cases namely asymptomatic or very mild symptomatic people as identified through the survey in the village, so that these people will not visit the CHC/PHC directly resulting in control & containment of infection to other people. In the process of testing of the inmates of CCH, if anybody is found positive in the test, he/she will be shifted to dedicate COVID Care Hospital immediately.

- 3. The CCH facilities can also be managed remotely through use of tele medicine facilities and by the field level health personnel namely PHCs and CHCs.
- 4. GP will be maintaining the COVID Care Home & service providers may be engaged by the GP to provide food, cleaning & sanitation, watch & ward and other relevant logistics related services.
- 5. The assets namely bed, mattress, water purifier, inverters, etc of closed TMC at the GP level may be transferred to CCH under the guidance of Sarpanch, GPNO and BDO.
- 6. The expenditures relating to setting up of CCH and its various services will be met out of State/Central Finance Commission Award Fund up to Rs.50,000/-.
- 7. Considering the reduction in the flow of the migrant workers/returnees to home beyond June, 2020, there will be a Cluster level TMC, as decided by the Collector depending on the number load for a cluster of GPs, to take care of the quarantine requirement, if any, and the same will be managed by the GP. This Cluster level TMC is to be located in any already functional TMC working from Cyclone & Flood Shelter or if not available from any suitable Government infrastructure.

In the above backdrop, all relevant officers at the District, Block & GP level are to be directed to take timely actions for setting up of CCH & Cluster level TMC at the earliest & also ensure functioning of these institutions as a strategy of larger community led COVID-19 management in Odisha.
