Sub:- Regular review of COVID-19 vaccine procurement and optimal utilization of indented vaccines by Private Hospitals – Reg.

**Ref:- D.O. No. T-22020/22/2021-IMM dated, 14th July, 2021 of the Govt. of India,
Ministry of Health & FW**

Madam/Sir,

With reference to the letter cited above on the subject, I am to say that under the Revised Guideline for National Covid-19 Vaccination Programme implemented since 21st June, 2021, domestic COVID Vaccine manufacturers may provide up to 25% of their monthly production of vaccines to Private Hospitals. In this context, MoHFW has issued a SOPs for demand aggregation of COVID vaccines to be procured by the private hospitals.

In this context, a letter along with SOPs for demand aggregation of COVID vaccines to be procured by the Private Hospitals had already been communicated from this Department vide No. 18492/H dated, 30th June, 2021. Also, an orientation of district officials and officials of Private Hospitals was conducted by Directorate of Family Welfare on 13th July, 2021. However, the response of Private Hospitals to participate in Vaccination programme is minimal. In order to accelerate the participation of Private Hospitals, following steps shall be taken: -

- Review the status of indenting, payments, supplies and utilization of doses supplied to / procured by Private Hospitals in daily basis.
- Monitor to increase the pace of vaccination by Private Hospitals
- Provide necessary support to Private Hospitals to organize workplace CVCs or near to home vaccination sessions.
- Additional vaccinators of Private Hospitals may be trained to augment the vaccination capacity.

You are, therefore, requested to regularly review the activities in your district / MC to accelerate the participation of Private Hospitals in your district / MC.

Dear Colleague,

Please refer to my earlier D.O letter No. T.22020/22/2021-IMM., dated 23rd June 2021, regarding review of availability of vaccine doses in Private COVID Vaccination Centers (PCVCs) and for ensuring optimal utilization of such vaccine doses. Please also refer to the communications of the Ministry regarding further facilitation of supplies to PCVCs through the aggregation mechanism. In this regard, following observations are brought to the attention of the States/UTs –

1. There continues to be a significant gap and underutilization of vaccine doses already available with the PCVCs. The extent of proportion of balance doses as against the supplies made to PCVCs in some states is as high as more than 50%. In some of the states, the balances are reflected as negative, which indicates that in these states the hospitals are not declaring full stocks on Co-WIN. The State/UT-wise status is enclosed at Annexure – 1.
2. The demand aggregation process for placement of indents, updation of payment status, recording of payment confirmation and dispatches by the manufacturers, is fully operational on Co-WIN portal. The State/UT-wise status in this regard is enclosed at Annexure – 2. It is observed that –
 - a. A large number of PCVCs have not yet indicated the quantity they target (Monthly Requested Quantity) to procure in July.
 - b. Of those who indicated the monthly requirements, against the total monthly requested quantity of 1.88 crore doses, indents have been placed for 71.65 lakh doses (38.00%). In 9 States/UTs having PCVCs, no indents have so far been placed.
 - c. Payments have been made by PCVCs for 28.23 lakh doses, 39.40% of the total indented quantity. In 13 States/UTs, the payment process is yet to begin or is negligible. Only in the States/UTs of A&N Islands, Assam, Goa, West Bengal and Kerala, more than 50% of indented quantity has been paid for.

In this context, States/UTs are again requested to review on daily basis, the status of indenting, payments, supplies and utilization of doses supplied to/ procured by the PCVCs and ensure that PCVCs are not only facilitated to procure the required number of vaccine doses but also that the doses are so procured are optimally utilized for improving the pace of vaccination. Necessary support may also be provided to private CVCs to organize workplace vaccinations or near-to-home vaccination sessions. Additional vaccinators may be trained in Private CVCs to augment the vaccination capacities of Private CVCs. The States/UTs may also organise training of staff of PCVCs for operation of the Co-WIN functionalities, wherever necessary.

It is reiterated that all of the above mentioned points need to be reviewed on daily basis at the State as well as District level. Please take note that the necessary reports for facilitating the review and monitoring process are now available on Co-WIN. Also, a technical help line (Phone no. 0120-4473222) has also been setup for resolution of any issues related to private CVCs. Please do reach out to us for resolution of any issues in this regard.
